Re: NHSP-M Visitation Schedule Effective August 16, 2021

The below revised visiting schedule for the New Hampshire State Prison for Men, in-person visitations to include attorney visitations will be effective August 16, 2021. All standards set forth in COR 305.00 *Access to the facilities and grounds of the NH Department of Corrections* apply.

Visit Eligibility for Residents:

- Must be eligible for visitation (not on any loss of visitation).
- All other criteria/restrictions outlined in the In-Person Visit Memo Dated May 5, 2021 no longer apply.

Visitation Guidelines:

- Visits will be available by residents housing units as outlined in the NHSP-M Visitation Schedule
- Access to visiting room will be subject to seating availability
- Visiting party is limited to three (3) people
- All individuals must remain seated at their assigned table
- Children's play area will remain closed at this time.
- Residents and visitors may engage in a three (3) second hug at the beginning and end of the visit.

Attorney Visits:

- Attorney visits will no longer need to be scheduled through the Wardens office
- Attorney Visits will be available during any available visiting room time for general population (MCN/MCS & HANCOCK). R&D and CCU attorney visits will be specific to the housing unit visiting room times.
- A dedicated area during all open visit room times, separate from personal visitation will be available in the visiting room for attorneys

Visitor Arrival and Visitor Screening Process:

- Upon arrival to the Visiting Room Entrance, Visitors will be required to successfully complete the NHDOC COVID-19 screening process (which includes a temperature check).
- Visitors are encouraged to perform proper hand hygiene prior to entering the facility.
- Face coverings will not be required to visit however; visitors who choose to wear a face covering will be given a surgical mask upon arrival and may dispose of upon exiting.
- Visitors are encouraged to social distance from other parties and follow all posted directives.

Resident Screening Process:

- Residents who choose to wear a mask to visit, will receive a surgical mask upon entry into the visiting room.
- At the conclusion of the visit, residents will discard their surgical mask and perform proper hand hygiene.

Sanitation:

- Cleaning and disinfecting will occur at the conclusion of each visit session.
- Proper hand hygiene is encouraged

The NHDOC reserves the right to terminate a visit if a visitor or resident displays symptoms that raise concerns regarding COVID-19 or violates visiting guidelines. NHDOC may implement visiting restrictions due to COVID 19 concerns.
